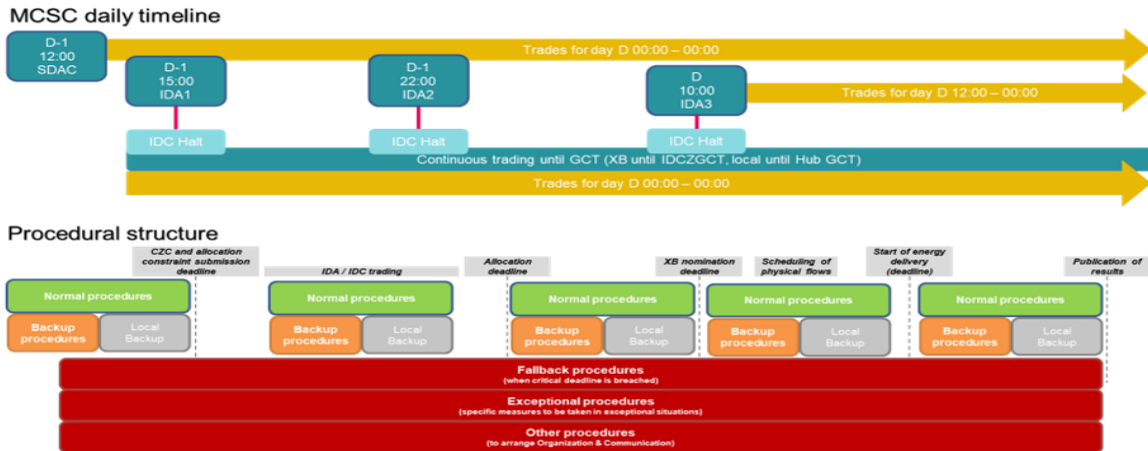

2. IDA report

2.1. General overview

This backup procedure will be executed by the IDA Coordinator at the end of the IDA session in case of issue with the IDA Report.

2.2. Process clarification

Case 1: Problem in creating the IDA Report

If the IDA Coordinator is not able to create the IDA Report, the IDA Coordinator sends an email to inform the other IDA NEMO Operators that he is not able to generate the IDA Report and that it will be generated as soon as possible.

If the file creation functionality is not available, the IDA Coordinator will directly contact the [REDACTED] as described in procedure IDA_NEMO_EXC_04 to identify and solve the problem.

Case 2: Problem in sending all the IDA Reports

If IDA Coordinator has created all the IDA Reports for the current delivery day but he is not able to send them by email, the reports can be sent the day after.

3.2. Process clarification

Case 1: No [REDACTED] Session Dump can be generated.

If the IDA Operator cannot create [REDACTED] Session Dump, he will need to follow local procedures at each IDA Operator, verifying configuration of the Algorithm Dump Collection Tool.

Case 2: [REDACTED] Session Dump cannot be compressed and encrypted.

If the IDA Operator cannot compress and encrypt [REDACTED] Session Dump the IDA Operator should contact their local IT department and ensure that the problem is fixed in order to provide the [REDACTED] Session Dump as soon as possible.

Case 3: [REDACTED] Session Dump cannot be transferred to the [REDACTED].

If the IDA Operator cannot transfer [REDACTED] Session Dump to the [REDACTED] because the [REDACTED] is unavailable, the zipped and encrypted file has to be sent by email to [REDACTED].
