DECISIONS

NEMO GOVERNANCE

- NEMO Committee re-confirmed the task force leaders of its task forces:
 - Cost TF Martin Vancura (PMO)
 - Governance TF Lajos Valent (OTE)
 - Legal TF Roberto Baldinelli (GME) and Régine Feltkamp (External)
 - o Tech TF Chiara Vitelli (GME) and Christoforos Zoumas (HEnEX)
 - o R&C TF Yovka Ivanova (IBEX)
 - MCCG NEMO Co-Chair Pierre Milon (EPEX)
- NEMO Committee approved the CACM Cost Sharing Keys for 2025, which will be used for quarterly invoicing of the ANCA, ANDOA and ANIDOA Costs.
- Fourth Amendment of All NEMO Cooperation Agreement (ANCA) was finalised and approved, signature process has been triggered. The merged NEMO Committee was consolidated in Q2 2025 as an early implementation of the new ANCA.
- Potential new NEMO from Denmark has reached NEMO Committee to clarify the process of becoming an
 Observer and receiving technical specification of the Intraday system. NEMOs were in contact with the
 Danish NRA to clarify the status and process of designation of the new NEMO. Any next steps depend on
 the finalisation of the designation process in Denmark.
- ACER has open call for volunteers to be part of the Cybersecurity Stakeholders Committee. NEMO
 Committee provided their expert Monika Peskova (OTE) as well as back-up resources Chiara Vitelli
 (GME) and Christoforos Zoumas (HEnEX).

REMIT

• NEMO Committee had a dedicated clarification call with ACER and EC representatives to clarify the REMIT Implementing act and the future REMIT reporting. NEMOs presented their proposal for reporting the data that individual NEMOs cannot access via 3rd Party RRM.

MCO INTEGRATION PLAN

- ACER informed NEMO Committee that Impact Analyses included in the submitted MCO Integration Plan are not satisfactory and therefore ACER cannot decide on the MCO IP.
 - NEMOs have clarified with ACER the reasons why the Impact Analyses were lacking certain details and ACER suggested potential ways for improvement.
 - NEMOs will perform additional simulations and aim to update the Impact Analyses by 10th November.

JOINT GOVERNANCE

• The NEMO vote on the proposed decisions within the agenda of the MCSC meetings was pre-aligned by the All NEMO Committee, which ensured the efficiency of the MCSC meetings.

OPTIMISATION OF DECOUPLING PROCESSES

• NEMOs, in cooperation with TSOs, are supporting ACER in exploring ways how to limit the probability of partial and full decouplings of the systems. Third PCG Workshop dedicated to this topic was held.

CONTRACTUAL NEGOTIATION FOR EUPHEMIA ALGORITHM SUPPORT

 Main focus of the NEMO Committee was on contractual negotiation with the service provider, that supports the operation and development of Euphemia. NEMOs have agreed prolongation of the contract, which ensures stability of the operation of the DA system.

METHODOLOGIES

 NEMOs have considered the Stakeholder's feedback received during the consultation into the updated HMMCP methodologies and are currently consulting them with TSOs. After TSOs provide their feedback, the updated methodologies will be submitted to ACER.

CORRECTIVE MEASURES

• NEMOs, in cooperation with TSOs, are working on preparation of SDAC and SIDC mitigation and corrective measures, in case the performance of the Day-Ahead, respectively Intraday system degrades.

CACM ANNUAL REPORT AND CACM COST REPORT FOR 2024

- NEMO Committee has finalised the CACM Annual report for 2024 and published it on 1st July.
- NEMO Committee has finalised the CACM Cost report for 2024 and published it on 30th June.
