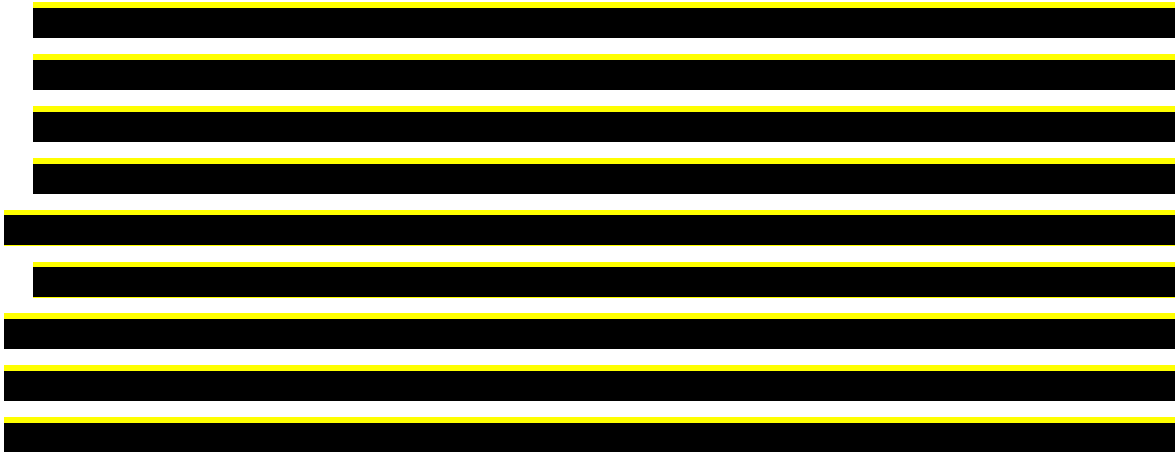

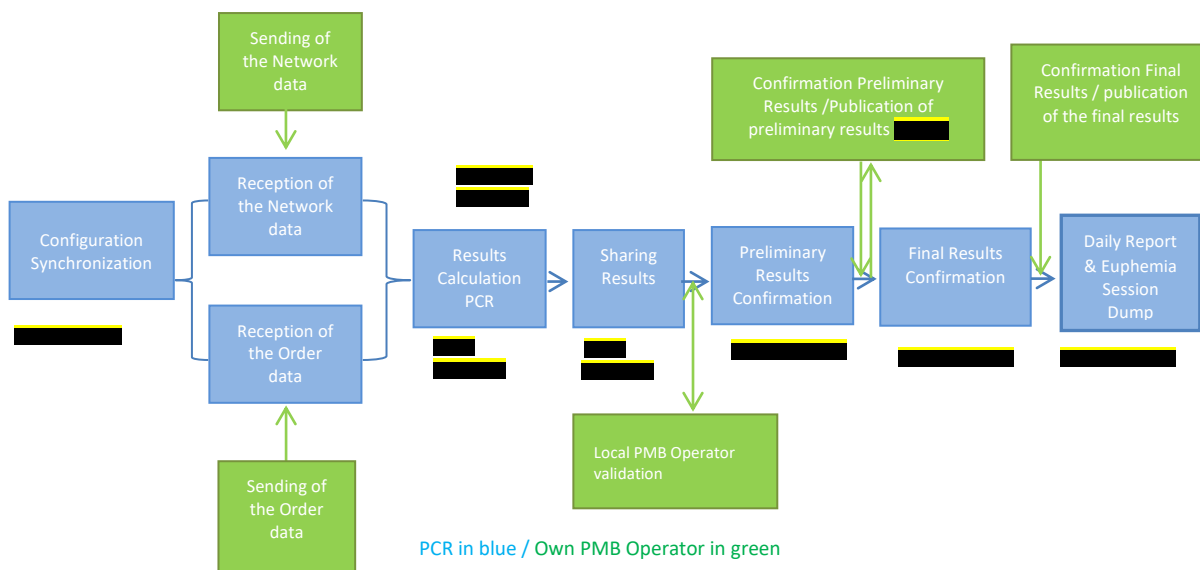

1. Introduction

This procedure describes how the PMB Operator creates a Daily Operational Report and the Euphemia Session Dump at the end of the Market Coupling Session.



1.1. Purpose

The purpose of this procedure is to describe the steps that have to be performed by PMB Coordinator in order to create the Daily Report and by all Operators the Euphemia Session Dump.

The purpose of the Daily Report is that the PMB Coordinator shares information with the other PMB Operators, in particular - to provide an overview of the process timings. Although officially it has to be executed by the PMB Coordinator, any PMB Operator is able to run it.

The Euphemia Session Dump has to be created by all PMB Operators in order to make it available for treatment by the Algorithm Working Group.

1.3. Associated procedures

- **In normal situation:**
 - o ANDOA_NOR_07: Final Confirmation of the Results: The previous process must have been successfully completed.
- **In backup situation:** as soon as an event happens that prevents the regular application of the procedure ANDOA_NOR_08, the PMB operators refer to procedure ANDOA_BUP_08.

2. Daily Report

2.1. Preconditions to start

The precondition to start this process is the successful completion of procedure *ANDOA_NOR_07: Final Confirmation of the Results*, in which the positive Global Final Confirmation of the results is distributed to all the PMBs [REDACTED] and from each PMB to the IT systems of each PMB Operator. No timing constraint is required to start this procedure but can only start as soon as the previous procedure ends.
